

**Lines in the Lagoon, Inc. Youth Fishing Tournament  
Minor Child Release of Liability and Permission Slip**

***PLEASE READ CAREFULLY AND COMPLETELY – You have the right to refuse to sign this form and the LIL Tournament Committee has the right to refuse to let your child participate if you do not sign this form.***

This form contains a release and waiver of claims which, when signed, contractually waives any claims against Lines in the Lagoon, Inc., its Board, agents, volunteers and partners as well as officials, committee members, sponsors and all persons directly or indirectly connected with the Lines in the Lagoon Youth Fishing Tournament (hereinafter referred to as the “LIL Tournament Committee”) that may arise in connection with your minor child/ward’s participation in activities at the Lines in the Lagoon Youth Fishing Tournament and related to activities scheduled for on or about September 24 – 25<sup>th</sup> 2021 (hereinafter referred to as the “Tournament”).

In consideration of the opportunity afforded to my minor child/ward to participate in activities at the Tournament, I, the undersigned, on behalf of my child/ward named herein below do freely subscribe to the following contractual obligation: I, on behalf of my child/ward named below, fully understand the risks associated with participation in any water-based activity, and know it is potentially dangerous, to include but not limited to personal injury or death and do hereby for my minor child/ward’s heirs, executors, and assigns knowingly, freely, and voluntarily assume all risk and liability for any damage or injury to person or property that may occur as a result of my child/ward’s attendance at and participation in activities at the Tournament, and do hereby release discharge, and covenant not to sue the Tournament Committee, and do hereby waive and discharge all claims for damages that my minor child/ward or I might have against the LIL Tournament Committee for any reason, including negligence, action or inaction of the LIL Tournament Committee, and agree to indemnify and hold harmless the LIL Tournament Committee for and against any and all claims, damages and judgments, of whatever nature, including attorney fees, that may be asserted or entered against any of them in connection with my minor child/ward’s participation in any activity associated with the Tournament, including the Captain’s Meeting and the Angler Awards Banquet to be held at Walking Tree Brewery. I understand that even if the Tournament Committee uses reasonable care in providing this activity, there is a chance my child may be seriously injured or killed by participating in this activity because there are certain dangers inherent in the activity which cannot be avoided or eliminated. By signing this form I give up my child’s right and my right to recover from the LIL Tournament Committee in a lawsuit for any personal injury, including death, to my child. Due to current Covid-19 restrictions I will act responsibly and my child and I will wear a face mask when social distancing guidelines of six (6) feet are unavoidable. No claims for the contraction of Covid-19 may be brought against the LIL Tournament Committee or its partners, sponsors or anybody affiliated with the Tournament.

I, on behalf of myself and/or my child/ward, have read the **Release and Waiver of Claims**, and fully understand its terms, and understand that I, on behalf of my child/ward, have waived substantial rights by signing this Release and I have signed it freely and without inducement, coercion, or assurance of any nature, and intend it to be a complete and unconditional release of any all liability, and agree that, if any portion of this Release and Waiver of Claims is held invalid by a court of competent jurisdiction, any portion not being held invalid shall remain in full force and effect. I agree to let my child/ward engage in a potentially dangerous activity and I will be solely responsible for them for the duration of the Tournament and during all activities associated with the Tournament.
